Fees: \$750 for a space (approx. 20 x 20 and includes 500 watts of electricity)
(You may purchase additional electricity from our supplier. Generators are not allowed.) Additional space is negotiable.

Businesses that are members of the Greater Edmonds Chamber of Commerce may deduct 20% from the booth fees. Discount does not apply to sponsor fees.

Application: Deadline for registration is **May 1st**. Complete, sign and date the application. Submit one photos of your product and one of your setup. If you wish your photos returned, include a self-addressed stamped envelope. Mail registration form and check for booth fee, by **May 1st**, to the address below. Notice of acceptance will be made the first of **June**. If you are not accepted, your fee will be returned to you by **June 30th**. No refund will be issued after acceptance.

Please note: You are responsible for supplying your own booth, tables, chairs, carpet, etc. Your booth must be designed to withstand wind and inclement weather and your displays should be adjustable for uneven surface grades.

Taxes: You are responsible for collecting and paying all applicable taxes. **UBI # (required)** _____
 The State of Washington Department of Revenue is asking that all special events provide them a list of vendors along with their State of Washington Unified Business Identification (UBI) number. If you do not have one, a temporary UBI# can be issued to you free of charge by going online to: www.dor.wa.gov and click on *DOING BUSINESS* – under *Business Type* click on *Temporary & Seasonal Businesses* then click *Register online*. You can also call 1-800-647-7706 and go to *Tax Services*.

Parking: Each vendor will be issued (1) parking pass. Parking is limited so it is first come first serve. Additional staff is encouraged to ride the shuttle buses from Edmonds Woodway High School. Map will be sent in vendor information package.

Motorhome: We have limited space for motorhomes. Restrictions apply and will be outlined in acceptance letter.

Insurance Certificate: Provide a certificate of insurance naming "A Taste of Edmonds" and its staff, Greater Edmonds Chamber of Commerce and City of Edmonds as an additional insured for an amount of not less than \$1,000,000.00.

Licenses and permits: you are responsible for securing all necessary licenses and permits to operate your business in Snohomish County and the State of Washington.

The Greater Edmonds Chamber of Commerce reserves the right to decline any application submitted by an entity, organization or business for any reason at the Chamber's sole discretion. A Taste of Edmonds tries to limit applications in a given field so as not to over saturate. Booth selection and placement may depend on the following not necessarily in this order (a) Sponsorship above & beyond the minimum booth fees (b) seniority as a past vendor at A Taste of Edmonds (c) Seniority as a member of the Greater Edmonds Chamber of Commerce (d) the order in which applications & fees are received.

VENDOR'S AGREEMENT

A Taste of Edmonds (TOE) festival is staged where the Greater Edmonds Chamber of Commerce (Chamber) is a rent-paying tenant conducting a business. Accordingly, the Greater Edmonds Chamber of Commerce reserves the right to deny access to any Entity for any reason to the legal extent any business has a right to deny service to anyone at a business location. As the authorized representative of a TOE vendor, referred to as "The Entity" in this Agreement, I agree to the following:

I understand and accept that any Entity wishing to apply to be present at A Taste of Edmonds to perform activities beyond that of a regular visitor or consumer will be denied access inside the festival layout unless:

- A Taste vendor application is signed by an authorized representative and received by the Greater Edmonds Chamber of Commerce before the established deadline;
- The Entity is a business with a certificate of insurance and insurance coverage as required by the festival organizers;
- The Entity is a business with all the required federal, state and local licenses and permits necessary to operate a business at A Taste of Edmonds;
- Inside the festival layout and during open hours of the festival, the Entity is only selling or promoting products or services that are fully disclosed on the application form, and is not selling, handing out, or delivering anything else and will hold harmless and indemnify the TOE for any liability stemming from the Entity's participation at the TOE;
- The products and services so sold are not, in the sole opinion of the Greater Edmonds Chamber of Commerce, subject to a controversy risk or a present a security concern. The Chamber reserves the right to review subjects of political purposes and religious purposes and any other controversial subject matter.

While at A Taste of Edmonds, if the Entity does not conform to the above policy, I agree that, if asked to do so, the Entity, for which I sign this Agreement as the authorized representative, will leave the premises immediately without refund of any participation fees and costs incurred at that time.

I understand and approve that applications received without a signed agreement or a valid payment will not be considered and that, without a certificate of insurance, the Entity will not be allowed at A Taste of Edmonds and, in such a case, participation fees already paid will not be returned. I certify that the information provided on the vendor application attached to this Agreement is true and complete.

Return your signed agreement, your application, your insurance certificate (see other page), one photograph of your booth and one of your product with your payment (see below) by May 1st. **Applications received without a signed agreement or a valid payment will not be considered. Without a certificate of insurance, the vendor will not be allowed at A Taste of Edmonds and, in such a case, participation fees already paid will not be returned.**
